2	Section 303 of the Magnuson-Stevens Fishery Con-
3	servation and Management Act (16 U.S.C. 1853) is

6	"(1) ANNUAL UPDATES.—Each fishery impact
7	statement prepared pursuant to subsection (a)(9)

3	"(B) selected by the Comptroller General
4	of the United States.
5	"(3) Determinations.—Each fishery impact
6	statement prepared pursuant to paragraph (1) or
7	subsection (a)(9) shall determine if the fishery man-
8	agement plan or amendment is consistent with sec-
9	tion 301(a)(8), including if the conservation and
10	management measures in the plan or amendment
11	provide for the sustained participation of fishing
12	communities and, to the extent practicable, minimize
13	adverse economic impacts on such communities.
14	"(4) MITIGATION PLAN.—Not later than 60
15	days after the date on which a statement is pub-
16	lished pursuant to paragraph 1, the Secretary shall
17	prepare, publish, and begin implementation of a
18	comprehensive mitigation plan to—
19	"(A) address any negative economic or so-
20	cial impacts identified in a fishery impact state-
21	ment prepared pursuant to paragraph (1); and
22	"(B) correct any inconsistencies deter-
23	mined pursuant to paragraph (3).".
